- 2. Quoted prices by the bidders should be valid for a minimum period of 90 days from the date of issue of the purchase order on execution of purchase agreement whichever is later.
- **3.** The Earnest Money Deposit (EMD) of Rs. 5000.00(Rupees five thousand only) should be enclosed along with the technical bids duly signed and stamped by the Bidder. The validity of EMD should be for three months. The EMD should be in the form of demand draft in favour of Navyug Kanya Mahvidyalaya, Lucknow.
- 4. - **17.** If the successful bidder fails to maintain the college smart class room as per the time framework given by college will be open for the College to cancel the order the defaulting bidder which includes forfeiting and the security deposit.
- **18.** Navyug Kanya Mahavidyalaya, Lucknow reserves the right to reject any times supplied against the purchase order, if found not satisfactory at the time of delivery. The rejected items, if any, shall have to be taken back and replaced by good quality items forthwith at the cost of the supplier. No payment will be made for the rejected item(s).
